Rel 12: Business Needs addressed

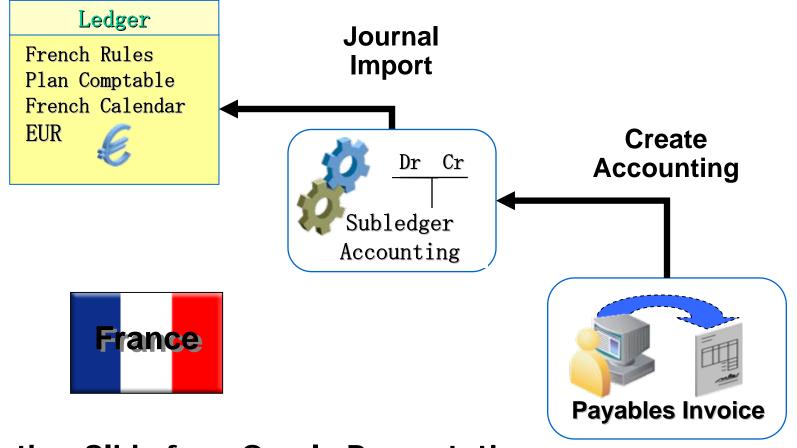
- Ledger Architecture Allocate, post, and report across multiple ledgers.
- Sub-Ledger Accounting Common rules-based engine that controls how financial transactions are accounted for.
- Multi-Org Access Control Perform multiple tasks across operating units without changing responsibilities while maintaining security of the line of business.
- Financial Consolidation Hub Support complex consolidations from Oracle and non-Oracle sources.
- E-B Tax Common rules-based engine for calculating tax. (from Oracle presentation at Oracle Open World 2007)

Let's make this simple

Not French Accounting principles, but general business needs on 4 examples:

Sub-Ledger Accounting

1) PO Receipt – Account for Purchase Price Variance by Product line or SEC Segment

2) AP Off-Set Accounting: include recoverable VAT

Multi-Org Access:

3) Receive payment for one legal entity's invoice into another legal entity's bank account

4) Re-Organization of Legal Ownership of Inventory Organization

Another Note for international implementations – (No practical experience yet)

- Sequencing
 - Sequence general ledger journals at posting or period close.
 - Sequence sub-ledger accounting journals at create accounting or period close
 - This may resolve many current issues and customizations around sequencing by accounting date:
 - Sequencing of external GL journal imports (journals are imported at month end with earlier GL dates)
 - Sequencing of sub-ledger entries (AP or AR Invoices) that are on initial holds or amended after initial entry date.
