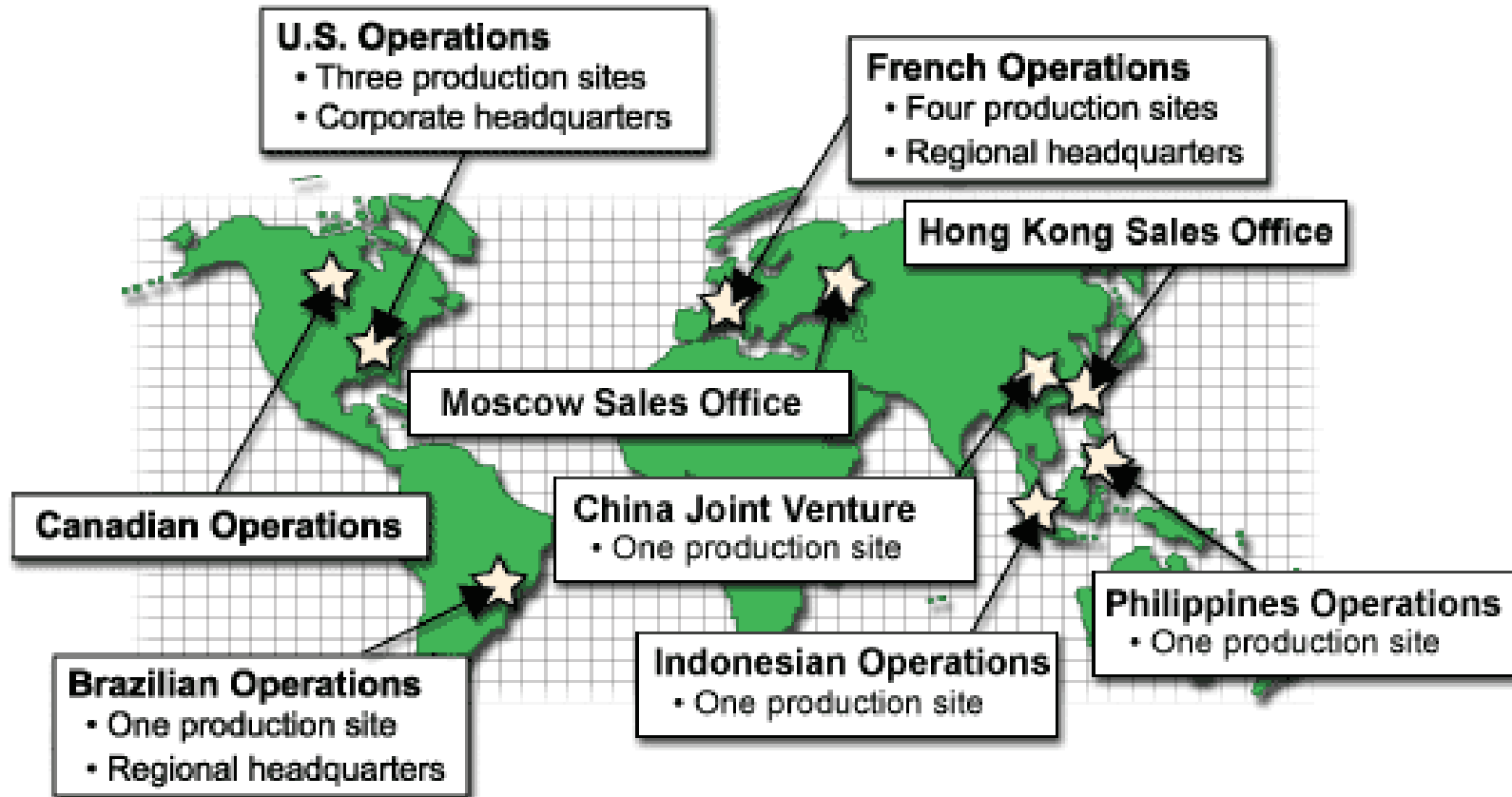

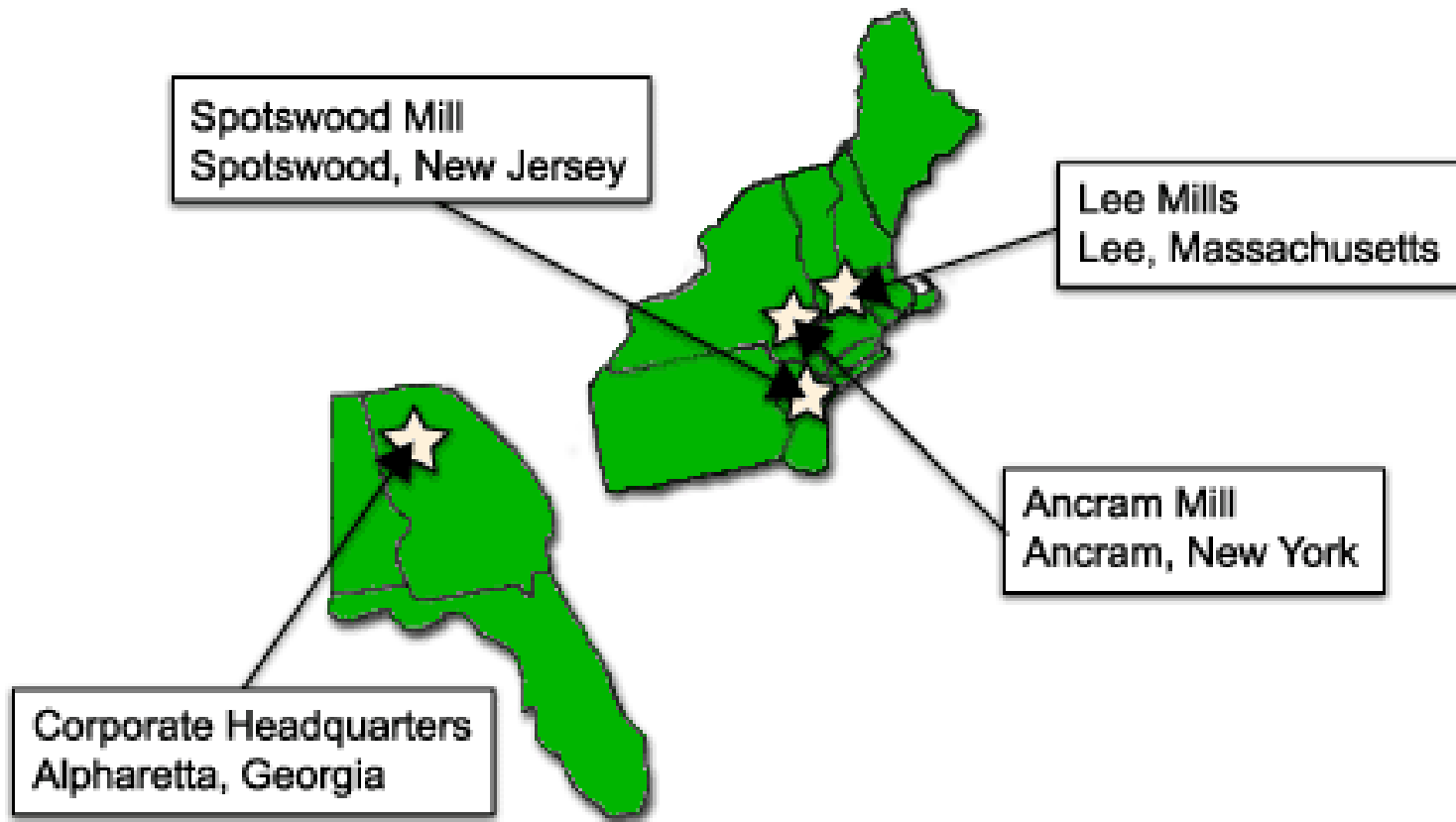
Background

- Upgrade Oracle Applications to 11.5.10
- Retire EMPAC 8.6.2 System
- Implement Oracle eAM
- Re-Implement Oracle Inventory
- Implement Oracle i-Procurement

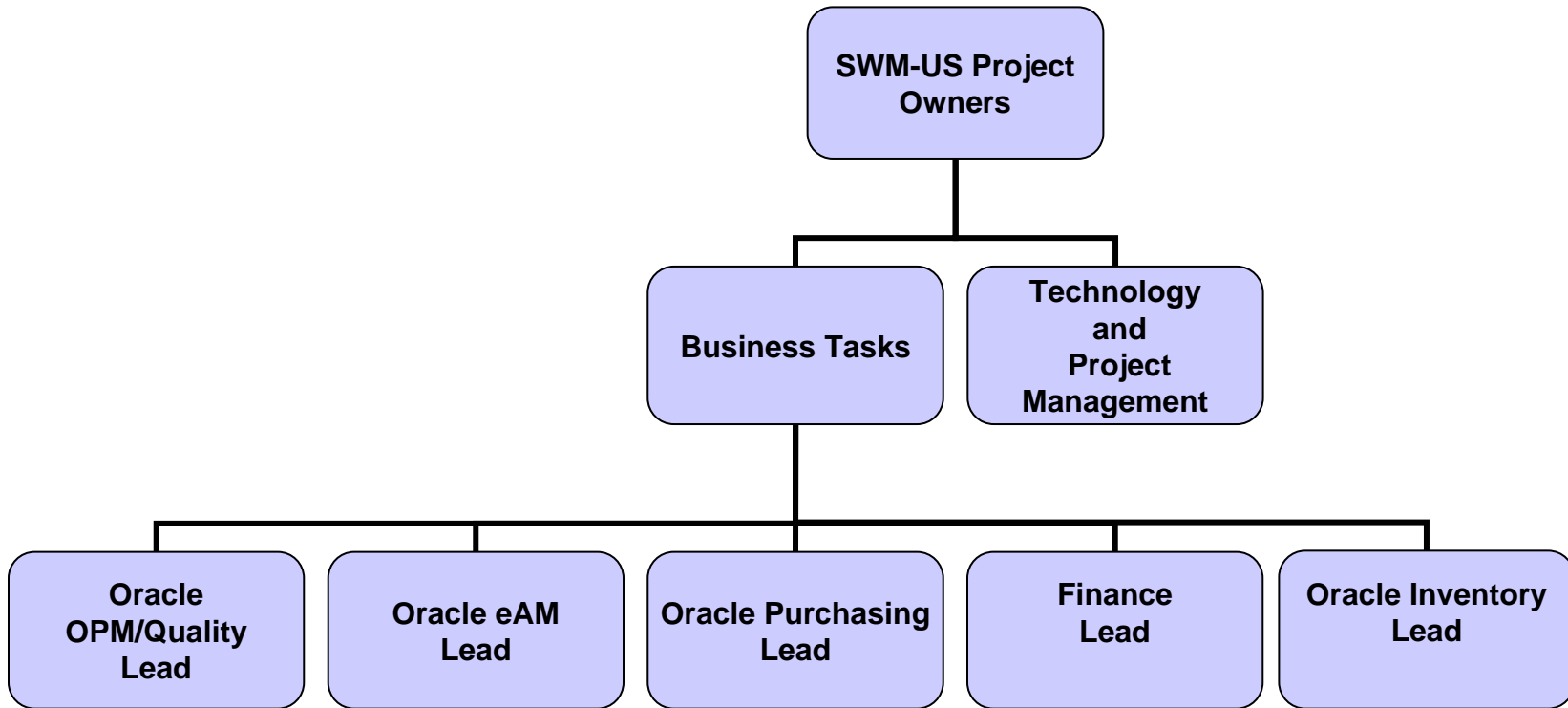
Project Scope

- Plan to Replace Indus EMPAC with Oracle eAM
- But EMPAC functions require new Oracle modules
 - eAM, INV, PO, Project Costing, i-Procurement
- Requires upgrade of Oracle Apps to 11.5.10
 - GL, AP, AR, FA, Cash Mgt, HR, OM, PO
 - OPM (OPM Inventory, OPM Quality, OPM Production Management)
- Requires changes to Custom Code (Labeling, Packing Lists, Direct Cert)
- Requires new purchasing process and Oracle Inventory implementation to replace Empac functions

Original Project Timeline

- CRP I- June 4- Aug 10
- CRP II- Aug 15- Sep 15
- CRP III- Oct 1- Oct 30
- CRP IV- March 1, 2008- March 30, 2008
- Go-Live- April 15, 2008

Project Results

- EBS Upgrade from 11.5.8 to 11.5.10.2
- 3 Separate Mills - Big Bang Go Live
- Project went live **6 months early**
- All inventory items converted with 99% accuracy
- No Customizations!
- Minimal post production support

Lessons Learned

- Clearly understand business processes before implementation begins
- Understand what information needs to be converted
- Have dedicated resources to support the project
- Change Management communications
