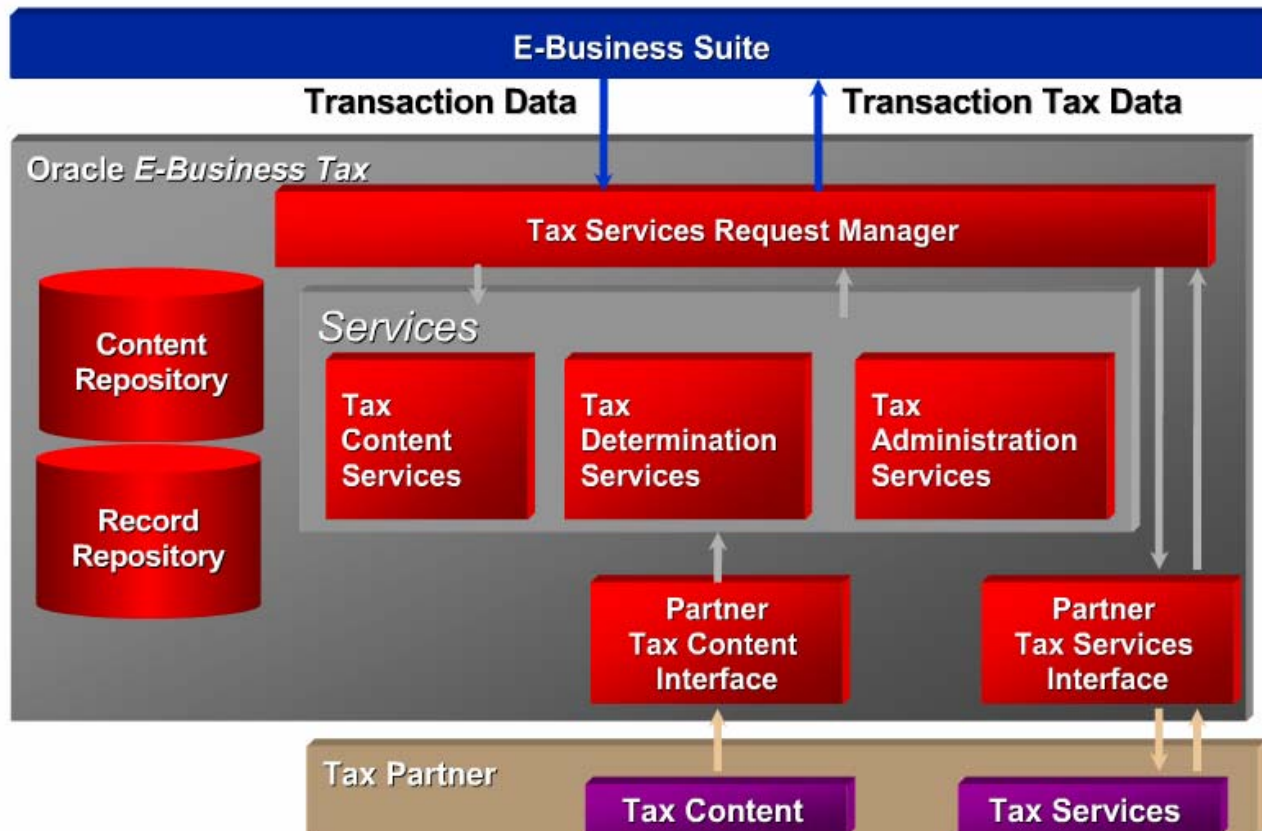

Party Tax Profile:

- Party tax profile is derived from Legal Entity, 1st Party Establishment and 3rd Party and party sites
- Party tax profile comprises tax registrations, exemptions and fiscal classifications
- It is core to the tax determination services

- Rule Templates
 - Reuse existing templates

- Setup Tax Users
- Tax System Profile Values
- Lookup Codes
- TCA Geography Hierarchy
- Legal Entity
- Operating Units
- Tax Accounts & Accounting Information
- TCA classification
- Oracle Inventory configuration
- Regime to Rate Flows

Migration of 11i configurations

- Support for tax configurations done in PO, AP, AR and PA during upgrade to R 12
- Procurement to Pay & Order to Cash setup migration
- Migration of tax codes, groups, rates and defaulting hierarchies as tax classification codes
- Tax determination and calculation based on tax classification codes
- Gradually migrate to regime to rate and tax rules model for modifications and changes

Country Specific Tax setups:

- Support for the following regimes:
- UK Value Added Tax (VAT)
- Canada Goods & Service & Harmonized Tax (GST and HST)
- United States Sales & Use Tax
